

Carbon Reduction Plan

The Aggreko group is committed to the global ambition of achieving Net Zero emissions by 2050. In support of this goal, Aggreko has set interim targets of:

- Net Zero emissions for Scope 1 and 2 by 2035; and
- 30% reduction in the emissions intensity of our energy solutions by 2030.

This Carbon Reduction Plan outlines our goals, progress, and strategies to reduce carbon emissions.

Baseline Emissions

Our baseline emissions were established in 2021. Since then, we have made significant progress in reducing our carbon footprint.

Carbon reduction initiatives

To achieve our carbon reduction goals, Aggreko is implementing several key strategies and initiatives, including:

For our own facilities and operations

- Investing in onsite renewable electricity generation and sourcing renewable electricity
- Transitioning to lower global warming potential (GWP) refrigerants for our temperature control products and minimising leaks
- Switching to lower-carbon fuels for product testing
- Electrifying company vehicles and equipment
- Enhancing energy efficiency across our operations

For our customer solutions:

- Investing in cleaner technologies and services that help customers to reduce costs, improve efficiency and lower emissions
- Trialling and adopting lower carbon fuels including HVO, biofuels, gas, methanol and hydrogen
- Collaborating with stakeholders to drive sustainable practices
- Providing critical data insights to monitor emissions and identify decarbonization opportunities

Aggreko is dedicated to reducing our carbon footprint and contributing to a sustainable future. We will continue to track our progress and update our Carbon Reduction Plan to reflect new developments and achievements.

Declaration

We monitor and report our greenhouse gas (GHG) emissions in accordance with the GHG Protocol Corporate Accounting and Reporting Standard (revised edition), using the market-based scope 2 calculation method, together with the latest emission factors from recognised public sources including the UK Department for Business, Energy and Industrial Strategy (BEIS), the US Environmental Protection Agency (EPA) and the Intergovernmental Panel on Climate Change (IPCC). We also track and monitor our energy consumption. These metrics are detailed in our [Greenhouse Gas Report 2024](#).

We monitor the carbon footprint of our facilities and operations including tracking energy efficiency, vehicle mileage, company vehicle composition, recycling rates, business travel and transportation and logistics. We also monitor our fleet composition, emissions from our customer solutions and the emissions intensity of our energy solutions as we seek to support customers to reduce their environmental impact.
